



Terms of use for electric charging stations

WHILE USING THE ELECTRIC CHARGING STATION, THE USER ACCEPTS THE PRESENT TERMS OF USE. (STATUS: 15.11.2021)

GENERAL CONDITIONS

Currently, 8 electric charging stations of the type [KEBA KC-P30, 11 KW, AC] are available in the underground car park and another 4 on the parking deck of the EUROPARK Salzburg shopping center. The use of the electric charging stations is exclusively permitted to private customers of EUROPARK Salzburg for the charging of electric single and multi-lane vehicles during their stay at EUROPARK Salzburg. The instructions of the employees of EUROPARK Salzburg and their vicarious agents must be followed at all times.

SAFETY PRECAUTIONS

The electric charging stations comply with the safety regulations in force at the time of installation [01/2021]. The electric charging stations have been installed by a professional company and are CE certified. The service of the electric charging stations is reserved exclusively for technically undamaged vehicles. The user is obligated to take all safety precautions, such as making a safe cable connection so that any risks of obstruction or injury to third parties are prevented. Faults and damage to the electric charging stations must be reported immediately to the customer information desk or the security staff.

TYPE AND DURATION OF USE

The use of the electric charging stations is fee required. There is no legal claim to the use of the electric charging stations. EUROPARK Salzburg reserves the right to interrupt, technically modify or completely cut off the electricity supply at any time without giving reasons. EUROPARK Salzburg does not provide a charging cable. The user shall use a technically faultless and suitable charging cable provided by him/her. Using of the electric charging stations, only the parking spaces provided for this purpose should be used. These may only be used during the charging process and for the duration of the stay at EUROPARK Salzburg. The electric charging stations are intended exclusively for occasional use. Continuous use, e.g. by residents, or commercial use are not permitted. EUROPARK Salzburg has the right to exclude individual persons or vehicles from the offer. In case of a violation of the terms of use, EUROPARK Salzburg reserves the right to bring an action of trespass, which the owner of the car has to pay, as well as to have the vehicle removed.

EXCLUSION OF LIABILITY

The use of the electric charging stations is at your own risk. EUROPARK Salzburg accepts no liability for any kind of damage incurred during the use of the e-charging stations.

BEHAVIOR IN CASE OF FIRE

In case of fire, immediately activate the fire alarm or call the fire department (122), indicating the location of the fire, the cause of the fire (car, building), the number of injured persons and your own name. If necessary and possible, warn endangered persons and evacuate helpless persons or injured persons. Try to extinguish the fire with a suitable fire extinguisher if your own safety can be guaranteed (caution: danger of electricity). Otherwise, leave the location on foot by the quickest route. Elevators may not be used in case of fire.

The house rules and any garage rules of EUROPARK Salzburg apply at all times.
